## Allegro Terms & Conditions

(...)

### Section 2. Terms & Conditions of participation in Allegro

(...)

2.9.

The User may register more than one Account provided that a different email address is assigned to each of them. Another Business Account may not be registered with the same NIP **tax identification number** until the verification process on the existing Business Account has been completed. However, the possibility of registering more than one Account is not available to an entity that possesses a tax identification number issued outside the European Economic Area, Switzerland, Ukraine, or the United Kingdom of Great Britain and Northern Ireland, or that has its registered office, registered business, or **actual place of business outside the aforementioned area, unless it obtains prior consent from the Company**. The User with an active Subscription service may, as part of signing into Allegro, switch between any number of Accounts without the need to sign into a given User's Account each time separately. In addition, they can authorize any person to use selected functions related to the processing of Transactions and Offers after signing into the Account. Users shall be fully responsible for any actions and omissions related to the mentioned functions performed by the authorized person.

The Company uses automatic mechanisms to detect whether a User has more than one Account.

The User may not use Accounts to perform acts that violate the Terms & Conditions. It is prohibited:

- a. to participate in an Auction using more than one Account;
- b. to bid or enter into a Goods sale agreement in the case of one's own Offers or Offers of close relatives or persons living with the User in the same household or other entities with which the Buyer is in relations resulting in well-grounded doubts that the parties act in agreement with the aim to affect the result of a given Transaction in violation of law or good practice, and add Ratings for such Transactions;
- c. to complete another Registration in order to avoid the payment of amounts due to the Company for the services provided on Allegro.
- d. using multiple Accounts to circumvent the terms of promotions, programs, or services provided by the Company on Allegro,



e. using Accounts to manipulate the popularity of offers, Sellers (including Seller quality statistics) or Ratings.

1. ~~Paid feature~~ **Paid feature** of the Offer **or feature of an Offer granted by the Company as part of promotional campaigns** (featured Offers are displayed first);
2. Seller's quality level;
3. Sales format of the Offer ('Buy Now' Offers are displayed first);
4. Condition of the Goods (Goods marked 'New' are displayed first);
5. Quality of the main photo of the Offer;
6. Price of the Goods;
7. ~~Users' interest in the Offer;~~ **Delivery cost of the Goods;**
8. Completion of obligatory Offer parameters;
9. ~~adaptation~~ **Adaptation** of the Offer parameters content to the type of business activity;
10. Best Price Guarantee offer feature;
11. **Information about** ~~expected~~ **estimated** delivery time.

## Section 5. Commencing a Transaction

(...)

5.4.

When performing the acts referred to in paragraph 5.1, the Seller shall order the Company to list the Offer on the date indicated by the Seller. If the date is not specified, the listing shall take place after positive verification of the Offer.



For a newly created Account, the number of simultaneously listed Seller's Offers may not exceed 20,000, and in the case of Sellers with a tax identification number issued outside the European Economic Area, Switzerland, Ukraine or the United Kingdom of Great Britain and Northern Ireland, or having their registered office, registered business or actual place of business outside the above-mentioned area, it may not exceed 500 without the Company's consent. If, during a period of 30 days from the date of publication of the first Offer on a newly created Account, the User who has a tax identification number issued in the European Economic Area, Switzerland, Ukraine or the United Kingdom of Great Britain and Northern Ireland, or has a registered office, registered business or actual place of business in the above-mentioned areas, under this newly created Account:

- a) maintains a sales quality level "Neutral" or higher, and
- b) does not violate the provisions of the Terms & Conditions regarding the linking of Offers with a Product and creating Products, and
- c) does not use incorrect GTINs in their Offers, the Company shall increase the limit referred to in the preceding sentence to 200,000 simultaneously listed Seller's Offers. The increasing of the limit of simultaneously listed Seller's Offer on a given Account above 200,000 and in the case of Sellers with a tax identification number issued outside the European Economic Area, Switzerland, Ukraine or the United Kingdom of Great Britain and Northern Ireland, or having their registered office, registered business or actual place of business outside the above-mentioned area, above 500, requires additional consent of the Company.

The number of Seller's Offers concerning the same Goods, listed in the same subcategory (regardless of the number of Seller Accounts held by that Seller), in the relevant Marketplace, may not exceed 2, and this limitation does not apply to Goods whose condition is marked with a parameter other than "New".

The limitation on the number of Offers for the same Goods does not apply to Offers that have been created on within Allegro Business, where Goods can only be purchased by Users holding Business Accounts. The User in one Business Account, for which the limit of simultaneously published listed Offers is 200,000 or more, may have 30,000 Offers as referred to in the preceding sentence. If the limit of simultaneously listed Seller's Offers on a Business Account is set to 20,000 or 500, it is also the limit of the number of Offers created on Allegro Business.

#### 5.10.

When completing the form in the [sales settings](#) Sales->Sales Settings->Delivery Settings tab, the Seller may specify fast dispatch hours (Same-Day Dispatch) which is a declaration that Goods will be dispatched on the same day provided that the Transaction is completed by the time (including the payment) specified by the Seller, which may differ depending on the carrier type, and the day of the week. Information about Same-Day Dispatch is visible in the Seller's Offer. The Company reserves the right to refuse to publish the information referred to in the preceding sentence if the Seller fails to meet the requirements specified at <https://allegro.pl/dla-sprzedajacych/godzina-wysylki-tego-samego-dnia->

In light of the fact that Buyers are provided with the Return Policy, as referred to in paragraph 5.11 above, the Seller that has a Business Account or a User conducting business operations shall be obliged to fill out the ~~relevant~~ Goods return form (available in the "~~Returns Terms~~" tab [the sales settings](#)) in total, and assign it to their Offers. Additionally, it is required to comply with the following rules:

## Section 10. Other obligations of Users

(...)

10.5.

The Seller is obliged to dispatch the order on the date declared in the Offer. Where, for the ordered Goods, the Buyer selects a delivery option which is registered by the carrier and has been given a tracking number, but this number has not been made available to the Company directly by the carrier, the Seller shall immediately enter ~~in the Orders tab (My Sales > Orders)~~ the correct tracking number (assigned by the integrated carrier after dispatch of the parcel) [in the sales settings](#).

## Section 11. Rating system

(...)

11.4

The Seller Rating is a subjective opinion of the Buyer about the course of the Transaction and the implementation of the agreement by the Seller. It consists of the "Recommended" or "Not recommended" badge ~~and a graphic rating of sales on a scale from 1 to 5 in the area of compliance of the Product with the description and service of the Buyer~~. Optionally, the Buyer may also post a descriptive review. A Buyer who chooses the "Not recommended" badge provides a rationale for this rating.

The Buyer may add a Seller rating after signing in to the Account, within no more than 90 days from the date of conclusion of the Transaction, the period being calculated to the nearest hour. It is not possible to add Seller Ratings if the Buyer has not concluded a Transaction with the relevant Seller or their Account has been suspended. The exercise by the Buyer of the right to withdraw from the agreement



does not affect the ability to add a rating. Seller Ratings are always linked to a particular Account and a specific Transaction.

The Seller who receives a "Not recommended" rating may respond to it once.

11.16.

**The** Buyers who have concluded at least one Transaction on Allegro in the past 12 months can rate Product Reviews, which affects their sorting according to the "~~most~~ helpful" criterion. The Company may remove a review of a product if it has been issued fraudulently, in particular with the intention of manipulating the sorting results.

11.17.

The Company uses a default sorting of reviews published in the "Product reviews" tab, according to the "helpful" criterion. The helpfulness of an opinion takes into account the following factors:

1. date of issue;
2. length and descriptiveness (we display longer reviews that contain more information about the Product first);
3. images and advantages or disadvantages of the Product;
4. ratings from other Users (we display reviews that we find helpful first);
5. proximity to the average Product rating;
6. rating of the Seller from whom the Product was purchased (we display reviews of Products purchased from better rated Sellers first).

The average current value in the circuit may not exceed 10mA and the energy may not exceed 300mJ. <b>The required element of description is information on name, amperage, and manufacturer. Declaration on the average current value in the circuit not exceeding 10mA and energy not exceeding 300mJ.</b></p>
