## Allegro Terms & Conditions

### Section 2. Terms & Conditions of participation in Allegro

(...)

2.11.

The Accounts shall be non-transferable save that, with the consent of or after verification of the Company:

- a. a Business Account User may change the form of their business via a transformation, division, or merger of the entity, in situations provided for by the provisions of Polish law,
- b. an enterprise operating with a Business Account may be acquired as part of inheritance,
- c. a Regular Account User may change the Account type to a Business Account for the sole purpose of making purchases under Allegro Business after completing the relevant form available at <https://allegro.pl/biznes/konwersja-konta>. The condition for the Account change referred to in the preceding sentence is that the User has not sold Goods on Allegro in the two years preceding the date of completing the form.
- d. The Business Account may be transferred in the event of transfer of rights and obligations related to the maintenance of the Account and Transactions carried out until the date of acquisition, by the User to another entrepreneur from the same capital group as the User. A capital group is defined as commercial companies interlinked by a control relationship (i.e., where one entity directly or indirectly holds more than 50% of shares in all related entities).

#### **Section 1. Offer description**

~~An Offer description The Offer must not include content that infringes law and the Allegro Terms & Conditions, and words, phrases, or expressions that violate moral norms (in particular in cases of unjustified offensive expressions, vulgarisms and their modifications, and diminutives) except for the~~



**"Erotica" category due to its specific nature), and drastic content. In the "Erotica" category, it is prohibited to include wording referring to minors in the Offer content.**

1.5.

Images included in an Offer must relate only to the offered Goods. Goods may be presented in the context of their use or arrangement. An image may present certificates, technologies, and graphic elements (e.g., arrows). Captions are forbidden, except for brand/manufacturer logos, colors and patterns, the number and unit and signs indicating the generation or modification of images using artificial intelligence services or systems or technologies. These rules do not apply to situations where separate agreements with parties cooperating with the Company specify different conditions for including images in Offers. **The images added in the Offer may not present intimate parts of the body.**

In the "Erotica" category, it is allowed to present the Goods in use, provided that the presentation is in the form of a drawing. Clothing, underwear, and footwear may be presented on a model, such as a person or a mannequin in a neutral position. Presentation of the Goods together with the packaging is allowed provided that the packaging meets the requirements set out in this Section. The images must not contain any content/elements referring to minors.

## Section 2. Images (thumbnails)

The Seller shall present their Goods on at least one image (thumbnail) posted on the server belonging to the Company. The image must meet the following requirements:

2.2.4.

The thumbnail may not contain any additional elements, in particular texts, graphic elements, frames, logos, etc., except signs indicating the generation or modification of images using artificial intelligence services or systems or technologies. **The thumbnail may not present intimate parts of the body.**

2.7.

Special rules for the "Erotica" category:

- a. The thumbnail may present only the Goods that are the subject of the Offer. Presentation of the Goods on a model — a person or mannequin in a neutral position, is allowed only for clothing and underwear;
- b. It is prohibited to present the Goods in the context of their use;



c. Presentation of the Goods together with the packaging is allowed provided that the packaging meets the requirements specified in sub-paragraphs a) and b);

d. The Goods may be presented in just one shot;

e. The thumbnail may not contain any content/elements referring to minors;

In the remaining scope, thumbnails must meet the requirements specified in Section 2.

## Section 3. Additional options

When creating an Offer and after its creation, the following additional options to distinguish an Offer visually on the list of Offers on Allegro shall be made available for a fee:

Feature — consists in placing an Offer on the list of featured Offers, i.e. in a clearly separated part of the list of Offers displayed above other Offers, covering only featured Offers, and on the list of featured Products, in the case of an Offer that is a Product Representative.

The Feature may only be used by Sellers who have an active Business Account that is not suspended or subject to a temporary restriction regarding access to specific services provided within Allegro and whose sales quality is defined as at least "Neutral". After the loss of the "Neutral" sales quality level, the Seller may continue to use the Feature for additional 7 days, only for the Offers featured on the last day of possessing the sales quality rated at least "Neutral".

Only Offers ~~available to all Users~~, with the Buy Now option ~~only~~, with the "New" Product status and not combined into a Product bundle are can be Featured.
